

#### City Centre

Surrey's Top location for retail & restaurant opportunities, home to Surrey City Hall, university and innovation districts, Central City Mall, Surrey Memorial Hospital, and a future medical school.

#### Cloverdale

Cloverdale Rodeo, annually welcomes over 100,000 visitors. Cloverdale also hosts Western Canada's biggest Canada Day celebration.

#### Fleetwood

Surrey's newest town centre and is expected to be one of the fastest growing with the completion of 3 new SkyTrain stations.

#### Guildford

Home to Guildford Town Centre – BC's second-largest shopping mall.



#### Newton

Home to the region's largest South Asian community. Newton hosts more than 400,000 to the largest Vaisakhi Parade outside India every year.



City Centre's population grew by 25% between 2016 and 2021. 8,498 Units and 585,854 square feet of office and retail space are currently under construction in the area. Surrey City Centre is Surrey's densest population hub, with over 35,000 residents—the same size as the City of Mission.



## **Consumer Insights Highlights**

### **Untapped Consumer Markets in Surrey**

- Surrey households spent a total of \$685 million in April 2025.
- Of the total amount spent by Surrey households, \$133 million was spent outside of Surrey and another \$56 million online.
- Of the total \$189 million of leakage in retail spending, 23% was in entertainment and recreation, and restaurant dining – significant unrealized opportunity for Surrey businesses in these retail subcategories.






## **Consumer Insights Highlights**
